Algeria's Vision 2035

Interview with H.E. Nor-Eddine Aouam,
Ambassador of Algeria to Germany, by Helene Rang



Ambassador Aouam, in cooperation with the World Bank, Algeria is currently preparing a study on the country's economy with its Vision and Plan of Action 2018–2035. Could you elaborate on the plans and strategies comprised in this vision, the envisaged projects and their implications for foreign investors?

You certainly know that Algeria has recently revisited its economic model. A new economic framework will have to meet several challenges and negotiate many constraints over the next 15 years: changes in its productive structure, the evolution of internal indebted-

ness, external solvency and an energy transition that will increase hydrocarbon exports and allow Algeria to join the train of the new world energy order. To help implement this strategy, a comprehensive study on the national economy is, as you said, being prepared in collaboration with the World Bank.

In this regard, Algeria has so far received technical support from the World Bank to carry out the study. Another study is being developed between the two parties on granting aid to low-income groups under a special programme, and let me underline that these two studies are financed by
