Gerhard Schröder, Honorary Chairman of NUMOV, led a delegation comprised of members of the board of NUMOV, the German Near and Middle East Association, which visited the State of Qatar, the United Arab Emirates and the Kingdom of Saudi Arabia from 11th to 15th January 2014. H.E. Gerhard Schröder has travelled the region extensively and is a warmly received guest of honour.

The delegation visits started in Doha, the State of Qatar, where **H.E. Dr. Mohammed Saleh Al-Sada**, the Minister of Industry and Energy of the State of Qatar, welcomed the esteemed delegation members. He is also the Vice Chairman of the Board of the Qatar Chemical Company (Q-

Chem) and Qatar Steel Company (QASCO) as well as Chairman of the Board of Directors of Qatar Metals Coating Company (Q-Coat), also holding the position as the chairman of the RasGas's board of directors.

The delegation was also invited by **H.E. Sheikh Mohammed bin Ahmed bin Jassim Al Thani**, the former Minister of Economy and Commerce. During his tenure, Sheikh Mohamed played an active leading role in several domestic and international issues pertaining to trade liberalisation within the World Trade Organisation (WTO) and free trade negotiations with several bilateral Qatari partners.
