German economic delegation organised by NUMOV visits Abu Dhabi, Dubai and Sharjah

NUMOV organised a high-ranking German economic delegation to the emirates of Abu Dhabi, Dubai and Sharjah from 31st October to 3rd November 2022 – formed by many business representatives from different sectors – with the objective of discussing new possible partnerships and investment opportunities.

The first visit was to the Abu Dhabi Investment Office on 31st October, an independent authority established in 2019 by H.H. Sheikh Khalifa bin Zayed Al Nahyan, President of the UAE, in order to increase foreign direct investment in the emirate by supporting investors and companies looking to establish or expand their businesses in the city. The delegation then attended the Abu Dhabi International Petroleum Exhibition and Conference, at which they met representatives from the Minister of Industry and Advanced

Technology of the UAE. In addition, the delegation visited renewable energy company MASDAR, meeting **Zoë Harries**, Director of the Free Zone at Masdar City, and participated in talks at the Ministry of Climate Change and Environment with **H.E. Eng. Eissa Al Hashemi**, Assistant Undersecretary for Sustainable Communities Sector and Acting Assistant Undersecretary for Green Development Sector and Climate Change at the ministry. The visit to Abu Dhabi concluded with an appointment on invitation of **H.E. Sheikh Khalifa bin Khalid Al Hamed**, Board Director of the Khalid Al Hamed Group.

In Dubai, the delegation participated in talks at the Dubai Roads and Transport Authority (RTA) – the main transport company in Dubai, founded by the UAE government in 2005 – on 1st November, accompanied by **H.E. Sybille Pfaff**,
